

How to **apply** for Norwegian Criminal record – and how to **send** in Criminal record(s)* to The Civil Aviation Authority (Luftfartstilsynet)

In order to process the application for background check you also have to apply for Norwegian Criminal record*.

You can only apply for Norwegian Criminal record if you have been registered resident in Norway **more than 6 months**.

- Validity Criminal record(s): **90 days** from the date it was issued.

* Luftfartstilsynet **need Criminal record(s) from all countries you have been registered in more than 6 months for the last five years.**



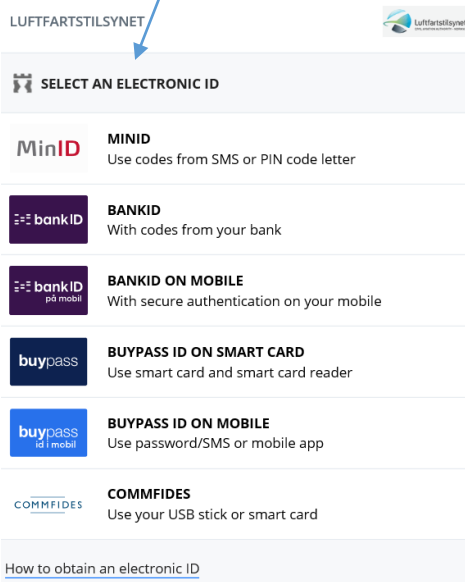
